## **Region XI Board Special Order**

**By special order of the Board per the newly adopted section of the Constitution and By Laws:**

**16-2.1 The Board, to ensure continuity of operations during times of a national emergency, catastrophic event or pandemic, may at an advertised meeting at which a quorum is present, may by a (2/3) majority vote amend, alter, reduce or extend timelines as specified within the Constitution and Bylaws. These amendments, alterations, reductions or extensions of timelines may only be in place for a specified time not to exceed one year. These temporary actions shall be enacted as a Special Executive Board Order and not be included in the body of the Constitution & By-Laws.**

**The following extension of timelines as established within the By-Laws under sections 4-4.0, 8-1.0:**

**The Board in order to maintain consistency in operations of Four Corners Region XI during the unprecedented times related to the COVID-19 pandemic, hereby extends the service period for the Office of Chair and Vice Chair for a period of 1 year or the next AGM.**
